SDSO SOLICITS ENDOWMENT GIFTS AND GRANTS TO PROVIDE FINANCIAL SUPPORT TO SDSO FOR THE ASSOCIATION'S PROGRAMS AND ACTIVITIES. SDSO IS A PUBLIC CHARITY UNDER SECTION 509(A)(2).

SDSF HAS AN INDEPENDENT BOARD OF DIRECTORS WHICH DOES INCLUDE THE CEO OF SDSO AND ONE OTHER DIRECTOR SELECTED BY THE SDSO'S BOARD OF DIRECTORS. THE GOVERNING DOCUMENTS PROVIDE THE BOARD HAS DISCRETION REGARDING THE TIMING AND AMOUNT OF DISTRIBUTIONS CONSISTENT WITH THE BOARD'S FIDUCIARY DUTIES. REPRESENTATIVES OF THE BOARD HAVE QUARTERLY FACE-TO FACE MEETINGS DURING WHICH THEY DISCUSS THE PERFORMANCE OF THE ENDOWMENT'S INVESTMENTS. PLEASE NOTE MEETINGS WERE CONDUCTED QUARTERLY ON ZOOM DURING THE COVID PANDEMIC. ALSO DURING THE QUARTERLY MEETINGS THE CEO PROVIDES AN UPDATE ON PROJECTS AND ACTIVITIES OF SDSO. SDSO'S CONTROLLER PROVIDES REPORTS ON THE PREVIOUS 12 ROLLING-QUARTERS AVERAGE VALUE OF ASSETS TO HELP DETERMINE THE DISTRIBUTION FROM SDSF TO SDSO FOR THE FOLLOWING FISCAL YEAR. THE PAYOUT HAS GENERALLY BEEN BETWEEN 5% AND 6%. SDSF'S BOARD COMMUNICATES REGULARLY WITH THE CFO OF SDSO REGARDING SDSF'S INVESTMENTS AND PLANS FOR DISTRIBUTIONS. SDSF'S QUARTERLY INVESTMENT STATEMENTS ARE PREPARED FOR, AND REVIEWED BY THE
